3-(2-Methoxyphenoxy)-1,2-propanediol is a slightly bitter, aromatic-tasting expectorant also known as Guaifenesin, the active ingredient in Robitussin and other cough remedies. A large dose can be harmful when swallowed, causing respiratory depression, altered sleep time, and chronic pulmonary edema. Intravenous exposure can cause ataxia, dyspnea, and hematuria. Subcutaneous exposure can affect the autonomic nervous system, acting as a smooth muscle relaxant.
Subacute to chronic toxicity: No effects known.
Additional toxicological information: To the best of our knowledge the acute and chronic toxicity of this substance is not fully known.
